City begins comprehensive plan update

In May, the City will begin a process to update the City's Comprehensive Plan. The 2030 Plan, adopted in 2008, is an overarching long-term plan for the future of Georgetown and contains the goals, policies and overall vision for the City's growth.

This 18-month update will include a population analysis, residential and commercial land use studies, and an analysis and strategies for the development of the city's gateway corridors including Williams Drive. The update to the 2030 Plan will result in a Future Land Use Plan and Implementation Plan which will guide City officials as they make decisions on where, when, and how the City should grow.

Throughout the update process, public outreach is planned to seek feedback on various parts of the plan and keep stakeholders aware of the process. More information will be available as the planning process kicks off in early summer.

Water Safety Day

The Georgetown Parks and Recreation Department will host Water Safety Day at the Georgetown Recreation Center Outdoor Pool, 1003 N. Austin Ave., from 10 a.m. to 1 p.m. on May 19.

The annual event helps kick off the summer swim season with a fun-filled, educational family event designed to increase public awareness about drowning prevention and water safety.

The event is free and open to all ages. Attendees can visit with vendors, then stay and swim in the outdoor pool. Children age six and younger must have a guardian actively participating with them in the water at all times.

In the event of inclement weather, Water Safety Day will be moved to the indoor pool area.

Call 811 before you dig

Call 811 before you dig. It's a free call, and it can save a life.

When you call 811, within 48 hours, utility companies are notified about your intent to dig and will send a locator to mark utility-owned underground electric lines, pipes, or cables in the work area, free of charge.

Utility companies will mark the location of their underground lines with paint, flags, or stakes using a standard color code, which you can see at Texas811.org. Customers should be aware of any unmarked lines not owned by a utility, such as a customer-owned connection to a water meter, a wastewater service tap, or an irrigation system.

If you are digging and damage a utility line, call the utility immediately. If you know it is a Georgetown Utility Systems line, call Customer Care at **(512) 930-3640**.

Just remember—know what's below. Call 811 before you dig.
